This matter came before the Board of Commissioners on January 30, 2008 at the request of Marlene Putman, Director of the Tillamook County Commission on Children & Families Director. The Board finds as follows:

1. The Tillamook County Commission on Children & Families' By-laws require that the Chairperson be recommended by the Commission and appointed by the County Commissioners and the presiding Juvenile Court Judge.
2. The Tillamook County Commission on Children & Families' By-laws further require that a Vice-Chairperson be nominated by the acting Chairperson and that the Commission on Children and Families recommend the Vice-Chairperson to the County Commissioners and Juvenile Court Judge for approval and appointment.
3. Shary Mason is willing and qualified to be appointed as the Chairperson for the Tillamook County Commission on Children & Families.
4. Frank Hanna-Williams is qualified and willing to be appointed as the Vice-Chairperson of the Tillamook County Commission on Children & Families.




