This matter came before the Tillamook County Board of Commissioners on April 2, 2008, at the request of Neal Lemery, Justice of the Peace.

The Board of Commissioners being fully apprised of the representations of the above-named person, the records and files herein, finds as follows:

1. It appears the Neal Lemery is now the duly elected Justice of the Peace for the Justice District of Tillamook County, Oregon.
2. ORS 51.260(2) permits the Board of Commissioners, when it deems it in the public interest, to appoint a person or persons possessing the qualifications for election to such office to serve as Justice of the Peace Pro Tem during a temporary absence or other incapacity of a Justice of the Peace.
3. ORS 51.260 requires that during the temporary tenure of the Justice of the Peace Pro Tem, that person shall receive the same salary as the absent Justice of the Peace would otherwise have received during that period.
4. It is in the public interest to appoint Tim Dolan, Deborah Dyson, Denise Harrington and Christian Hooley to act as Justices of the Peace Pro Tem from January 1, 2008 through December 31, 2008.

NOW THEREFORE, IT IS HEREBY ORDERED that:

5. Tim Dolan, Deborah Dyson, Denise Harrington and Christian Hooley are appointed to act as Justices of the Peace Pro Tem from January 1, 2008 through December 31, 2008.
6. Tim Dolan, Deborah Dyson, Denise Harrington and Christian Hooley shall be paid at the same rate and compensation as the Justice of the Peace, Neal Lemery, for those days they serve as Justice of the Peace Pro Tem.
