This MATTER CAME BEFORE THE Tillamook County Board of Commissioners on Wednesday, July 14, 2008 at the request of Jennifer Purcell of the Tillamook County Solid Waste Department, for a Notice of Intent to Award a Contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:


1. Tillamook County advertised its Call for Bids in the Headlight Herald, a local newspaper on June 11 and 18, 2008. Therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed two (2) copies of its proposal solicitation documents in response to all telephone and personal requests for copies.
3. During the Call for Bids period, Tillamook County received no objections or other concerns regarding the Bid documents timely raised by potential proposers or other interested persons.
4. Tillamook County received one (1) timely bid which met minimum qualifications.
5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the Contract to the proposer with the lowest price.
6. The proposal of Westwind Concrete, Inc. for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

7. Notice of Intent to Award a Contract for the construction of a sixty x eighty-four (60' x 84') foot, fully enclosed pole building, cement perimeter, and retaining wall be and is hereby adopted. The Board's Executive Secretary is directed to promptly send by first-class US Postal Service mail a copy of this Order to the successful proposer and all proposers who provided an address.
8. This Notice shall constitute a final decision of Tillamook County if no written protest of the Notice of Award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within fourteen (14) calendar days of the date of this Notice of Award pursuant to local contracting rules.

9. Westwind Concrete, Inc. shall submit the required insurance certificates and executed Contract in order that a signed Contract is presented to the Board of Commissioners at its regular meeting on Wednesday, July 30, 2008.
10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.


