RESOLUTION

This matter came before the Board of Commissioners for Tillamook County, Oregon, on the 28<sup>th</sup> day of July, 2004, at the request of Tassi O'Neil, Tillamook County Clerk, and William K. Sargent, Tillamook County Counsel.

The Board, being fully apprized of the representations of the above named person(s), finds as follows:

1. Tillamook County People's Utility District (TPUD) has determined that it is necessary to shut off all electrical power to the Tillamook County Courthouse on Friday, August 13, 2004, between the hours of 11:00 a.m. and 2:00 p.m., for necessary electrical work.
2. The normal hours for recording documents in the Tillamook County Clerk's office are 8:30 a.m. to 4:30 p.m.
3. ORS 205.242 (1) requires that the Tillamook County Clerks' office be available to do recordings for a minimum of six hours a day.
4. ORS 205.242 (2) requires that a resolution be enacted by the Board of Commissioners whenever the minimum hours of recording must be reduced.

NOW, THEREFORE, IT IS HEREBY RESOLVED that

5. The Board of Commissioners for Tillamook County, under the authority of ORS 205.242(2), hereby directs that the Tillamook County Clerk's Office reduce the hours of recording on August 13, 2004, to accommodate the work of TPUD.
6. It is further resolved that the hours of recording on August 13, 2004 shall be 8:30 a.m. to 11:00 a.m. and 2:00 p.m. to 4:30 p.m.
