This MATTER CAME BEFORE THE Tillamook County Board of Commissioners on January 14, 2009 at the request of Paul Levesque of Board of County Commissioners Department, for a Notice of Intent to Award a Contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:

1. Tillamook County advertised its Call for Bids in the Headlight Herald, a local newspaper and in the Daily Journal of Commerce on December 10, 2008. Therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed fourteen (14) copies of its proposal solicitation documents in response to all telephone and personal requests for copies.
3. During the Call for Bids period, Tillamook County received no objections or other concerns regarding the Bid documents timely raised by potential proposers or other interested persons.
4. On January 6, 2009 Tillamook County issued Addendum #1 prequalifying three (3) additional bleacher manufacturers for a total of five (5) authorized to bid on this solicitation.
5. Tillamook County received three (3) timely bids which met minimum qualifications.
6. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the Contract to the proposer with the lowest price.
7. The proposal of Southern Bleacher Construction Company, Inc. for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

8. Notice of Intent to Award a Contract for the design, fabrication and delivery of four (4) sets of ground level bleachers be and is hereby adopted. The Board's Executive Secretary is directed to promptly send by first-class US Postal Service mail a copy of this Order to the successful proposer and all plan holders who provided an address.

9. This Notice shall constitute a final decision of Tillamook County if no written protest of the Notice of Award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within seven (7) calendar days of the date of this Notice of Award pursuant to local contracting rules.
10. Southern Bleacher Construction Company, Inc. shall submit the required insurance certificates and executed Contract in order that a signed Contract is presented to the Board of Commissioners at its regular meeting on January 28, 2009.
11. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.


