This matter came before the Board of Commissioners for Tillamook County, Oregon, on the 4th day of March, 2009, at the request of Jerry Underwood, by and through the Tillamook County Fair Board.

The Board of Commissioners, being fully apprised of the representations of the above-named person, finds as follows:

1. The seven (7) sets of portable bleachers are no longer needed for the Tillamook County Fair.
2. Yoncalla Rodeo Committee from Yoncalla, Oregon would like to purchase the three (3) larger, newer bleachers that measure twenty-eight feet six inches by fifty-four feet (28'6" x 54'). They would disassemble and haul away the bleachers and pay the sum of Twenty-Five Hundred (\$2,500) Dollars, which funds would be deposited to the Tillamook County Fair account.
3. The four (4) smaller bleachers that measure nineteen feet by twenty-four feet (19' x 24') would be donated to Tillamook High School as scrap metal to be used in the Tillamook High School charity drive to raise funds for Doernbecker Children's Hospital and scholarships.
4. The Sophomore and Junior students disassembled the bleachers on Sunday, February 15th, 2009. The Sophomore class should receive one thousand (1,000#) pounds for a total of Forty (\$40) Dollars and the Junior class should receive five thousand four hundred (5,400#) pounds for a total of Two Hundred Sixteen (\$216) Dollars.
5. On February 11th, 2009 the Board of Commissioners signed Order #09-017 directing that the proceeds of the student's disassembled bleachers be divided between all four (4) classes for the Charity Drive. Order #09-017 should be rescinded.
