This MATTER CAME BEFORE THE Tillamook County Board of Commissioners on July 6, 2009 at the request of Liane Welch of Public Works (Road) Department, for a Notice of Intent to Award a Contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:


1. Tillamook County advertised its Call for Bids in the Headlight Herald, a local newspaper and in the Daily Journal of Commerce on June 17, 2009 and June 24, 2009 respectively, therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed twenty-eight (28) copies of its Bid solicitation documents in response to all telephone and personal requests for copies.
3. During the Call for Bids period, Tillamook County received no objections or other concerns regarding the Bid documents timely raised by potential proposers or other interested persons.
4. Tillamook County received four (4) timely Bids which met minimum qualifications.
5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the Contract to the Bidder with the lowest price.
6. The bid of Jeff Carter Construction, Inc. in the amount of Two Hundred Eight Thousand Eight Hundred Thirty Eight (\$208,838) for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

7. Notice of Intent to Award a Contract for the culvert replacement be and is hereby adopted. The Board's Executive Secretary is directed to promptly send electronically, a copy of this Order to the successful Bidder and all plan holders who provided an address.
8. This Notice shall constitute a final decision of Tillamook County if no written protest of the Notice of Award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within seven (7) calendar days of the date of this Notice of Award pursuant to local contracting rules.



9. Jeff Carter Construction, Inc. shall submit the required insurance certificates and executed Contract in order that a signed Contract is presented to the Board of Commissioners at its regular meeting on July 15, 2009.
10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.




