This matter coming to be heard this 26th day of August, 2009 at a regular meeting of the Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD). The SWSD Board being fully apprized of the records and files herein finds as follows.

1. In violation of Tillamook County Solid Waste Ordinance No. 4, Section 8.01, on the premises at 409 McCormick Loop Road, Tillamook, designated as 1S9 28CB 100, there exists an accumulation of solid waste creating a condition of unsightliness and posing a threat to the health, safety and welfare of the people and the natural and scenic resources of Tillamook County.
2. The solid waste violations include, but are not limited to: empty plastic totes, trailers, scrap metal, non-operable farm equipment, non-operable vehicles, plastic drums, tires, fencing and RV trailers.
3. Randy Montgomery Boge is the person responsible for the solid waste violation.
4. Randy Montgomery Boge and Ruth Montgomery Boge are the owners of 1S9 28CB 100 and are, therefore, responsible for the abatement of the violation.

NOW THEREFORE, IT IS HEREBY ORDERED that


1. The owners, Randy Montgomery Boge and Ruth Montgomery Boge, fully abate the solid waste violations existing at 409 McCormick Loop Road, Tillamook, on or before Monday, September 21, 2009.

2. In the event that the period of time established for abatement by this Board Order passes and the owners, Randy Montgomery Boge and Ruth Montgomery Boge, have not fully abated the violation in that time, the Tillamook County Solid Waste Administrator shall proceed with County abatement of the violation per Tillamook County Solid Waste Ordinance No. 4, Section 9.04.
