This matter coming to be heard this 26th day of August, 2009 at a regular meeting of the Board of Commissioners, sitting as the governing body of the Solid Waste Service District (SWSD). The SWSD Board being fully apprized of the records and files herein finds as follows.

1. In violation of Tillamook County Solid Waste Ordinance No. 4, Section 8.01, on the premises at 8365 Bewley Creek Road, Tillamook, designated as 2S9 18 1700, there exists an accumulation of solid waste creating a condition of unsightliness and posing a threat to the health, safety and welfare of the people and the nature and scenic resources of Tillamook County.
2. The solid waste violations include, but are not limited to: 55 gallon drums (some empty and some containing assorted mixed waste), plastic 55 gallon drums, metal 55 gallon drums, auto parts, scrap metal, tires, partially cut up storage tanks, propane tanks, large plastic totes, vehicles (partial and whole), trailers and wood waste.
3. Randy Montgomery Boge is the person responsible for the solid waste violation.
4. Mary Ann Boge is the owner of record for 2S9 18 1700 and is, therefore, responsible for the abatement of the violation.

NOW THEREFORE, IT IS HEREBY ORDERED that


5. The owner of record, Mary Ann Boge, fully abate the solid waste violations existing at 8365 Bewley Creek Road, Tillamook, on or before Thursday, October 1, 2009.

6. In the event that the period of time established for abatement by this Board Order passes and the owner of record, Mary Ann Boge, has not fully abated the violation in that time, the Tillamook County Solid Waste Administrator shall proceed with county abatement of the violation per Tillamook County Solid Waste Ordinance No. 4, Section 9.04.
