This MATTER CAME BEFORE THE Tillamook County Board of Commissioners on the 14th day of October, 2009 at the request of Information Services Department, for a Notice of Intent to Award a Contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:


1. Tillamook County distributed five (5) copies of its Bid solicitation documents in response to all telephone and personal requests for copies. Therefore, notice of solicitation for bids was properly solicited.
2. During the Call for Bids period, Tillamook County received no objections or other concerns regarding the Bid documents timely raised by potential proposers or other interested persons.
3. Tillamook County received two (2) timely Bids which met minimum qualifications plus two (2) bids which did not meet the required criteria.
4. The Bid submitted by Dell Computers, Inc. did not meet the specified criteria for integrated monitor speakers and case dimensions/style and is therefore rejected as non-responsive.
5. The Bid submitted by CDWG did not meet the specified criteria for warranty, processor speed, DVD-RW speed, power supply, server access licenses and case type/style and is therefore rejected as non-responsive.
6. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the Contract to the Bidder with the lowest responsive bid..
7. The bid of Computer Technology Link in the amount of Sixty-Seven Thousand Seven Hundred Thirty-Two (\$67,732) Dollars for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

8. Notice of Intent to Award a Contract for the purchase of sixty-five (65) desktop computer systems for the Courthouse and Health Department be and is hereby adopted. The Board's Staff Assistant is directed to promptly send by e-mail, a copy of this Order to the successful Bidder and all plan holders who provided an address.

9. This Notice shall constitute a final decision of Tillamook County if no written protest of the Notice of Award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within seven (7) calendar days of the date of this Notice of Award pursuant to local contracting rules.
10. Computer Technology Link shall submit the required insurance certificates and executed Contract in order that a signed Contract is presented to the Board of Commissioners at its regular meeting on October 28, 2009.
11. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.

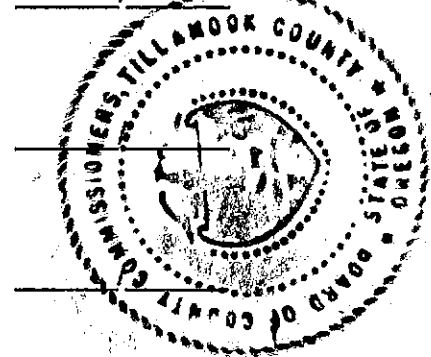




