This MATTER CAME BEFORE THE Tillamook County Board of Commissioners on Wednesday, October 28, 2009, at the request of Jennifer Purcell of the Public Works, Solid Waste Department, for the purposes of terminating the Request for Proposals for Household Hazardous Waste Facility Design at the Tillamook Transfer Station.


The Board being fully advised in the premises, records and files herein, makes the following findings:

1. Tillamook County conducted an informal solicitation for bids, contacting seven (7) qualified contractors between the dates of July 1 and July 9, 2009.
2. Tillamook County distributed seven (7) copies of its proposal solicitation documents.
3. During the Request for Proposal period, Tillamook County received no objections or other concerns regarding the Request for Proposal documents timely raised by potential proposers or other interested persons. One (1) addendum was released and distributed to all plan holders on July 7, 2009.
4. Tillamook County received two (2) timely proposals which met minimum qualifications.
5. Tillamook County entered into contract negotiations with the most qualified proposer, SCS Engineers, on July 15, 2009.
6. Tillamook County is rejecting the proposal of SCS Engineers being unable to negotiate a contract for the full scope of services described in the Request for Proposal within the designated budget.
7. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to terminate the solicitation for Household Hazardous Waste Facility Design at the Tillamook Transfer Station.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

- 8. Notice of Intent to terminate solicitation for Household Hazardous Waste Facility Design Services be and is hereby adopted. The Board's Staff Assistant is directed to promptly send by e-mail, a copy of this Order to all proposers.






