


Temporary Dance Hall Permit was granted to the Swiss Society for the evening of December 31, 1966 at the South Prairie Grange Hall.


Mr. Soule of Nestucca Valley Construction Co. submitted a \$500 bond in connection with laying of pipe line at Pacific City.
