CALL TO ORDER: By Chair O'Neil at 8:05 a.m. in Commissioners' Meeting Room B.

ITEM NO. 1: ANNOUNCEMENTS/INTRODUCTIONS: There were none.

ITEM NO. 3: (TAKEN OUT OF ORDER) NEW AND/OR REVISED PERSONNEL POLICY ADOPTION PROCEDURES: David Dickman said they are not ready. He asked for a subcommittee to review them. Paul Levesque, Sara Charlton, Tassi O'Neil and Bill Sargent are the members of the subcommittee.

OTHER: Mr. Dickman said on September 25 they were unable to have the Community Development Director interviews and described why they could not be held. The interviews have been rescheduled to October 15. There will be a Leadership Team panel from 8:00 a.m. to noon. He described the qualifications of the candidates.

ITEM NO. 4: HUMAN RESOURCES HOURS OF OPERATION and ITEM NO. 5: TRAININGS: These hours will be through the end of November. They may not need additional help during Human Resource training. Mr. Dickman will cover the office.

OTHER: Mr. Dickman said on Wednesday they will be asking for a new staff person. He described why they need a Human Resources Assistant 32 hours per week.

ITEM NO. 6: (TAKEN OUT OF ORDER) SPACE COMMITTEE UPDATE: Paul Levesque said the Surveyor move was just about complete. Dan McNutt said arrangements have been finalized with TLC Federal Credit Union to store archived maps in TLC's mechanical room but they still need to be moved from the Third Street storage unit. Mr. Levesque also reported the Surveyor is up and running at TLC.

ITEM NO. 2: ACTIVE SHOOTER VIDEO: Andy Long showed the video and encouraged the sharing of this with their employees.

ITEM NO. 7: (TAKEN OUT OF ORDER) VIDEO CAMERA SECURITY SYSTEM

POLICY UPDATE: There was a discussion about the fact that the policy was a work in progress. Denise Vandecoevering said she wants a camera at the tax counter because of all of the money they handle. There was a discussion about whether the current state court system would come under the policy. Commissioner Labhart said we really need to take our time on this policy.

ITEM NO. 8: NEWSWORTHY DEPARTMENT UPDATES: Liane Welch said Third Street is not paved and is 30 days behind due to lack of certified rock. The Public Works Department is failing to keep up with all of the demands being placed on it. She supports a new person in Human Resources due to internal support that Human Resources provides to her department. She described the few paving projects they were able to complete.

Dan Krein is busy and is working short staffed. State funds are drying up and they haven't been able to do prevention. Things are getting worse. Andy Long said there is a juvenile crime spree.

Bill Sargent reported tort claims are down. The Supreme Court will rule December 3 in NEDC v. Brown.

Travis Porter described the HVAC and generator seasonal work. The tile in the Surveyor's office is being examined for asbestos and possible removal.

Denis Vandecoevering distributed a chart (see attached) on Real Market Value (RMV) versus Assessed Value (AV). They will certify the tax roll by the 8th. AV went up 2.75%. She doesn't think the two will meet as she expects RMV to increase again. She said the closer the two values get the more likely there will be Measure 5 compression.

Del Schleichert said the temporary workers will be laid off today. It has been a good year which continues. He didn't think it would be as good next year.

Chair O'Neil asked to have a budget meeting before the end of the year. Deb Clark will schedule it.

Commissioner Labhart discussed the controversies with the Territorial Sea Plan and ocean energy industry. If it does not succeed, the Federal Energy Regulatory Commission (FERC) will entirely control ocean energy development. Adoption of the

Department of Land Conservation Department maps and Territorial Sea Plan is slated for January.

Commissioner Labhart talked about a technique for issue resolution involving fair play, quality of life, ability to make choices and sense of security. These are what create issues. These are what you address when they become complex issues. The FEMA appeal hearing is on October 12.

Commissioner Labhart will be involved for the next two days with the Oregon Department of Fish and Wildlife regarding the multi species management plan.

Andy Long said things are not slowing down. He talked about training. They are in the Lunsford murder trial. He described the status of recruitments and training on use of force. The Tillamook Animal Shelter looks promising.

Commissioner Labhart said the roads committee is meeting once per month.

Neal Lemery said they have been really busy. They are the second county in Oregon with etickets. He described how well it works. The legislature will look at decreasing the state share of the ticket money. Ms. Welch said her department gets about \$1,500 per month from the tickets. Sheriff Long described the benefits of the technology fund. Judge Lemery said the money goes into 29 different pots.

Commissioner Hurliman said the O&C Board met with the Governor. The O&C Board has come up with a management plan which he described involving 1.2 million acres. The Governor is apparently on board and supports clear cuts. The environmental community is fragmented. Commissioner Hurliman felt the acreage should be larger. The bill still needs some work.

Commissioner Hurliman also reported on corn silage issues with water being added and the resulting hazard on Highway 22. A lot of trucks are being ticketed. Trucks in Tillamook County have tubs and liners.

Commissioner Hurliman also talked about zoning the ocean. He felt that fishing permits will end up in the courts concerning the Territorial Sea Plan zoning.

Commission Labhart said he will be attending O&C meetings.

Mr. Dickman said retirement statements will be coming this month. There will be a workshop on retirement. There is an open enrollment this month. There is no rate increase through December 2013. If there are no changes, you do not need to log on. Mr. Dickman reported on his possible retirement next year.


